



## PLANNING & ZONING COMMISSION VACANCY

### Description

The City of Driggs currently has a vacancy on its Planning and Zoning Commission. This Commission reviews and makes recommendations on land use and development applications, assists in updating the City's Comprehensive Plan, and proposes amendments to related ordinances.

### Requirements

Pursuant to Idaho's Local Planning Act (Idaho Code Title 67, Chapter 65), the City of Driggs requires that an appointed P&Z Commission member must:

- a. Have resided in Teton County, Idaho for at least two years prior to his/her appointment,
- b. Be a resident of the City of Driggs or the Driggs Area of Impact (for the one Area of Impact representative), and
- c. Remain a resident of the City of Driggs or Driggs Area of Impact (for the one Area of Impact representative while serving on the commission.

### Responsibilities

P&Z Commission meetings are conducted on the 2<sup>nd</sup> Wednesday of each month, from 6:30pm to approximately 9:00pm. Members currently receive \$25 per meeting as an expense reimbursement. The P&Z Commission consists of five members, each appointed to a three year term by the City Council.
